Dear Parents and Carers,

I hope you and your families are managing to stay well.

Previously we have sent information about our Community Classroom which enables the children of key workers and those who are vulnerable to come into school when necessary. **From June 1<sup>st</sup> 2020, it is expected that all children deemed to be vulnerable attend our “Community Classrooms” each day.** Where a child has an allocated Social Worker, the school will also seek their support in encouraging the child to attend. This programme still remains open to children of key workers. We know that key worker’s timetables/shifts change so we want to make sure we are giving you the opportunity for this access on a weekly basis.

If your child falls into the categories outlined below and you would like your child to benefit from the supervision and support available from staff, while completing their work in school in the week after half-term starting **Monday 8<sup>th</sup> June**, you must let Miss Laidley know on [candice.laidley@evelyngraceacademy.org](mailto:candice.laidley@evelyngraceacademy.org) as soon as possible and by **Friday 5<sup>th</sup> June 2020** at the latest so we can plan the number of staff who will be required to be in school. It is crucial that you let us know as we cannot guarantee places unless you confirm to us that you will need one.

We all have our part to play in helping to stop the spread of Coronavirus. This means we must follow the government advice to **stay alert, control the virus, save lives.**

A reminder of the details for children who can be sent to school;

1. **Children who are vulnerable:** Full details of which children are covered are set out below.
2. **Children whose parents are key workers and who meet ALL the following conditions:**
  - The parent must be in a critical role based on government advice - full details of these critical roles are below; **and**
  - The parent must have had confirmation from their employer that their specific role is necessary for the continuation of essential public service; **and**
  - Their child **cannot** otherwise be cared for safely at home.

## **Government Guidance on Vulnerable Children**

Vulnerable children include children who are supported by social care, those with safeguarding and welfare needs, including child in need plans, on child protection plans, 'looked after' children, young carers, disabled children and those with [education, health and care \(EHC\) plans](#).

## **Government Guidance on Key Workers**

### **Health and social care**

This includes but is not limited to doctors, nurses, midwives, paramedics, social workers, care workers, and other frontline health and social care staff including volunteers; the support and specialist staff required to maintain the UK's health and social care sector; those working as part of the health and social care supply chain, including producers and distributors of medicines and medical and personal protective equipment.

### **Education and childcare**

This includes childcare, support and teaching staff, social workers and those specialist education professionals who must remain active during the COVID-19 response to deliver this approach

### **Key public services**

This includes those essential to the running of the justice system, religious staff, charities and workers delivering key frontline services, those responsible for the management of the deceased, and journalists and broadcasters who are providing public service broadcasting

### **Local and national government**

This only includes those administrative occupations essential to the effective delivery of the COVID-19 response or delivering essential public services such as the payment of benefits, including in government agencies and arm's length bodies

### **Food and other necessary goods**

This includes those involved in food production, processing, distribution, sale and delivery as well as those essential to the provision of other key goods (for example hygienic and veterinary medicines)

### **Public safety and national security**

This includes police and support staff, Ministry of Defence civilians, contractor and armed forces personnel (those critical to the delivery of key defence and national security outputs and essential to the response to the COVID-19 pandemic), fire and rescue service employees (including support staff), National Crime Agency staff, those maintaining border security, prison and probation staff and other national security roles, including those overseas.

### **Transport**

This includes those who will keep the air, water, road and rail passenger and freight transport modes operating during the COVID-19 response, including those working on transport systems through which supply chains pass.

### **Utilities, communication and financial services**

This includes staff needed for essential financial services provision (including but not limited to workers in banks, building societies and financial market infrastructure), the

oil, gas, electricity and water sectors (including sewerage), information technology and data infrastructure sector and primary industry supplies to continue during the COVID-19 response, as well as key staff working in the civil nuclear, chemicals, telecommunications (including but not limited to network operations, field engineering, call centre staff, IT and data infrastructure, 999 and 111 critical services), postal services and delivery, payments providers and waste disposal sectors.

If workers think they fall within the critical categories above they should confirm with their employer that their specific role is necessary for the continuation of this essential public service.
